Format	Events 1-5 do not require a rating fee or USATT membership. For event #6 (GRR), players will be placed in groups of up to 9 . The tournament committee will place un-rated players. All games will be to 11 and all matches will be best of 5 games unless altered by the tournament committee. You may not enter more than one event with the same start time. Deadline date for entries is Feb 15th . No walk-ins.
Rules	All USATT regulations apply
Eligibility	Open to all USATT and ITTF members. Non-members may purchase a membership at the tournament, see fee schedule below. Most current USATT ratings will be used to determine eligibility. Un-rated players who win their round robin will not be eligible for awards. The winner of a round robin MUST be a rated player. The tournament committee reserves the right to limit eligibility in all events! If you're in need of a partner for the doubles event, the tournament committee will try to match you up with someone. Entrants may only enter a single event starting at the same time.
Equipment	Only USATT approved equipment will be used: 8 Joola Blue Top/4 Butterfly/4 Stiga tables/Stiga nets/White 40mm Butterfly balls. 8 tables on Pulastic synthetic flooring. 8 tables on wood flooring.
Clothing	USATT dress code applies. Clothing must be other than white in color. Sneakers are required.
Awards	Trophies or cash prizes as noted, see event sheet for details.
Refunds	Will be made prior to the start of the tournament only. Events with insufficient entries may be cancelled and fees refunded.
